### Survation Ltd 13 Marginal Seats Poll (NHS) August 2014

2,644 adults were interviewed by telephone in a selection of 13 marginal Conservative-held seats, between 21st and 30th July, 10 of which are Labour targets and 3 of which are Lib Dem targets. A minimum of 200 interviews were conducted in each constituency. Results have been weighted by age and sex to be representative of all adults living in the group of 13 seats. Please note that the voting intention figures presented below are not a projection but are the weighted results of the voting intention question asked in this survey.

Our poll shows a 9 point swing from Conservatives to Labour across the 13 seats. If repeated in May 2015, Labour would win all 10 of their marginal seats in this list; Amber Valley, Warwickshire North, Broxtowe, Lancaster & Fleetwood, Brighton Kemptown, Lincoln, Morecambe & Lunesdale, Sherwood, Thurrock and Cannock Chase.

The LibDems would fail to win any of their three target seats, Camborne & Redruth, Truro & Falmouth or West Dorset, as our poll shows a 4 point swing away from the LibDems towards the Conservatives.

If the same swing was repeated across their full target list, this swing would be enough to deliver Labour 100 Conservative held marginals, enough to give them a convincing national majority. However, there may well be local factors operating in these and other seats that means a greater variation is likely across all marginal seats in Britain than simply extrapolating from these results would indicate.

### **TTIP Questions**

"Representatives from the European Union and the US government are presently negotiating a new trade agreement called TTIP (Trans-Atlantic Trade and Investment Partnership), aimed at making it easier to trade between Europe and the USA, which they estimate could bring an extra £4 billion a year to the UK economy.

One of the areas this new agreement could affect will be the NHS and health sector in the UK. If the NHS is included as part of this trade agreement, US private healthcare companies would be guaranteed the right to bid to run privatised NHS services. If a future UK government tried to stop the practice of allowing private companies to run these NHS services, US healthcare firms would then be able to sue the UK government for lost business opportunities."

- <u>Opposition to inclusion is highest</u> with those intending to vote Labour and UKIP (78% and 77% respectively)
- <u>Support</u> for inclusion is <u>highest</u> with those intending to vote Conservative (23%)
- Support for inclusion in highest among young 19% of 18-34s support the inclusion of the NHS
- <u>Opposition to inclusion is highest in Truro and Falmouth (81%)</u>
- <u>Support</u> for inclusion is <u>highest</u> in Lincoln (23%)

- 74% of those intending to vote Labour and 73% of those intending to vote UKIP think Cameron should seek to exclude the NHS from the agreement
- 78% of residents in Truro & Falmouth and 72% in Cannock Chase thought the same way

- 65% of those intending to vote Labour, and 60% of those intending to vote UKIP would support a Cameron veto
- Support for a veto is stronger among men (59%) than women (49%)
